

FROM THE SOUTH

- NYS Thruway to **EXIT 23** onto I-787 North towards **DOWNTOWN ALBANY/RENSSELAR/TROY**.
- Travel approximately 2 miles and take **EXIT 4/ US-9N / US-20W**.
- Stay in the **LEFT** lane and continue on the ramp for approximately ¼ mile until you come to a traffic light.
- Turn **LEFT** at the traffic light and you will be on **BROADWAY**.
- As you travel under the bridge on **BROADWAY**, bear right. (You will still be on **BROADWAY**.)
- At the 2nd light, turn **LEFT** onto **HUDSON AVE**.
- Continue down **HUDSON AVE**. At the end of the street, make a **RIGHT** onto **SOUTH PEARL STREET**.
- Make a **RIGHT** at the flashing yellow light, onto **BEAVER STREET**.
- Travel another 2/10th's of a mile to **GREEN ST**. (Our building will be on your left as you are traveling the short distance on **BEAVER ST**.)
- Take a **RIGHT** onto **GREEN ST**. and another immediate **RIGHT** into the **HUDSON-GREEN PARKING GARAGE**.

FROM THE NORTH

- Take **I-87 SOUTH**
- Take **EXIT 7-6/WATERVLIET (RT-2W)/SCHENECTADY/TROY/COHOES** onto **RT-7E** toward **EXIT 7/TROY/COHOES**.
- Travel approximately 4 miles and take the **ALBANY/COHOES** exit onto **I-787 SOUTH** toward **ALBANY/WATERVLIET**.
- Continue for approximately 1 mile and take **EXIT 3B/US-20 WEST/MADISON AVE/PORT OF ALBANY**
- Continue **STRAIGHT** through first and second light.
- Immediately after second light, bear **RIGHT** toward **US-20 EAST**. (McDonald's will be on your right.)
- You are now on **SOUTH PEARL STREET**.
- Continue through 3 lights, and make a **RIGHT** at the fourth light, a flashing yellow light, onto **BEAVER STREET**.
- Travel another 2/10th's of a mile to **GREEN ST**. (Our building will be on your left as you are traveling the short distance on **BEAVER ST**.)
- Take a **RIGHT** onto **GREEN ST**. and another immediate **RIGHT** into the **HUDSON-GREEN PARKING GARAGE**.
